Full payment will secure the team starting position in the order they are received. The half-payment option is available until May 1st, 2011 and balances must be paid in full by this date. All entries received after May 1st, 2011 must be paid **in full** at time of entry. All one-day tournaments are open to 75 teams. All two-day tournaments are open to 125 teams.

Refund Policy:

Cancellations made more than 60 days prior to tournament date will receive a half payment refund. No refund given if team cancels less than 60 days prior to tournament date. No switching tournaments after entry has been processed.
